Distribution for half year ended 31 December 2018

Evans and Partners Asia Fund (**Fund**) advises that the distribution for the half year ended 31 December 2018 was 2.6 cents per unit. The distribution of 2.6 cents per unit was initially announced on 19 December 2018 and was paid to unitholders on 4 February 2019.
